216/22 CLARIFICATION OF ACTIONS FROM LAST MEETING

Cllr. Josephson reported on the warm spaces scheme:

- Holy Trinity open every day 10-4 in Church Hall
- Baptist Church Monday & Wednesday for 1-2 hours
- Java & Jazz has a homework room in their upstairs room
- Community Centre Spring Room open while Centre open for working (has wi-fi)
- St Dunstans Ashurst Wood open every day 10-4
- Both church halls will provide hot drinks
- Andrew Clark from the Baptist Church (Member of Christians against Poverty) was available to help people apply for grants and debt management.

Cllr. Davies asked for a list of the Warm Spaces to be advertised more widely.

Cllr. T Lewin advised that there had been an SLR (Strengthening Local Relationships) meeting with East Sussex County Council on 28th November. He also invited everyone to join the Community Speedwatch team.

217/22 COMMITTEE CHAIRMANS COMMENTS

- All major decisions were on hold until after the elections in May 2023
- Late Night Shopping was being held on Thursday 1st December until 8pm. Cllr. Josephson advised that if over £10 was spent and a receipt produced from any of the shops, the eateries in the village were giving 10% off discount for 3 days after the event.

218/22 FINANCIAL REPORT

This had been previously circulated and was NOTED.

219/22 FOREST ROW MARKET

The November market had been successful despite the terrible weather. The business model going forward was still not finalised.

220/22 GAGES COMMUNITY LUNCHES / THURSDAY CLUB

A report from Sandra Aylen covering these areas had been previously circulated and was NOTED. It was felt that there should be a wider review of Gages at the next meeting.

222/22 REPORT ON 'SHED' PROJECT

A meeting had been held last week of Cllr. Waters, Hopkins, T Lewin and 2 architects. Mid-Sussex Timber had offered a portacabin to get started – planning permission would have to be sought. This would be on a platform as it would be in a flood risk area. Cllr. Waters advised that he was not sure when it would be available as it depended on building work timings at their yard.

Cllr. R Lewin proposed that a Working Group be formed of Cllrs. Hopkins, T Lewin & Waters with the architects. This was seconded by Cllr. T Lewin and AGREED

Cllr. Josephson proposed that outline planning permission be applied for with pre app advice if/as appropriate. This was seconded by Cllr. R Lewin and AGREED
