FOREST ROW PARISH COUNCIL TEMPORARY SCHEME OF DELEGATION

This Scheme of Delegation has been approved at the first meeting of the Full Council elected on 4th May 2023, to enable the ordinary business of Council to be maintained on a delegated basis until the revised organisational structures are agreed at the adjourned Annual Meeting in June 2023. [References herein to the former Scheme of Delegation (the 'former Scheme') shall be to the numbered paragraphs of the Scheme approved by Council on 5th July 2022].

During the period between the first meeting and the adjourned meeting referred to above ('the interim period') the following provisions shall apply:

- The Clerk as Proper Officer of the Council and Responsible Financial Officer, or in his absence the Assistant Clerk, shall continue to exercise the specific duties and powers of those offices in accordance with paragraphs 1 & 2 of the former Scheme.
- 2. All former Standing Committees of the Council shall stand suspended, and no business shall be transacted, nor decisions taken in the name of any purported Committee, PROVIDED THAT in the case of a genuine emergency in a personnel matter, as identified by the Chair of Council and/or the Clerk, the Chair and Vice-chair of Council may co-opt another elected Member to form an *ad hoc* Personnel and Grievance Committee and deal with the identified emergency in accordance with the provisions of para. 5.1.1 of the former Scheme.
- 3. The temporary Planning Group set up at the first meeting shall continue to meet as required during the interim period, and shall discharge its business on the Council's behalf in accordance with the provisions and powers of para. 5.5 of the former Scheme.
- Save as aforesaid, all powers and duties conferred on and exercised by the former Standing Committees under the former Scheme shall be vested in and exercisable by Full Council PROVIDED THAT during the interim period:
 - 4.1. All routine business, authorisations, expenditures, supervision, and correspondence within the remit of the Standing Committees under the former Scheme shall be dealt with by the Clerk in accordance with the provisions of para.1.2 of the former Scheme.
 - 4.2. All expenditures within budget where payment is required shall be signed off in the normal way by the temporary bank signatories appointed at the first meeting.
 - 4.3. Any specific non-routine matters where, in the opinion of the Clerk and/or the Chair of the Council action is required and cannot be deferred, shall be treated as 'urgent matters' as defined in para 6 of the former Scheme, and dealt with as set out in therein, save that references to Committees, their members or their activities shall be of no effect and only the Clerk, the Chair and Vice-Chair and members of Full Council shall be involved in any such matters.
- 5. For the avoidance of doubt:
 - 5.1. The non-statutory provisions of Standing Orders shall have advisory effect only during the interim period, and shall be applied at the discretion of the Chair in consultation with the Clerk where in their opinion the ordinary business of Council requires it.
 - 5.2. This temporary Scheme of Delegation shall continue in force and effect until it is replaced by a resolution of amendment or replacement in Full Council.
