86/20 CLERKS REPORT ON MATTERS OUTSTANDING WHICH DO NOT REQUIRE A DECISION

- 1. <u>Ashdown Surgery access</u>. There was much discussion on this subject. Cllr. Hill proposed that we should suggest to the surgery that an engineer sketch a drawing of the plans for Parish Council approval. This be done with a view to laying ground reinforcement grids and include enlarging the visibility splays. The Parish Council would then consider granting a wayleave at a nominal rent.
- BT exchange forecourt: This has been chased up, and a substantive response is awaited.

- 3. <u>Outdoor gym (and playpark) equipment repairs:</u> These have not yet been done due to the adverse weather conditions. NOTED
- 4. <u>Hopyard verge</u>. The absence of signs has now led to a degradation of the verge by parked vehicles. As soon as weather & ground conditions permit, some anti-vehicle posts will be installed. NOTED
- 5. <u>Skatepark extension</u>: The family have raised more than half their projected budget and have now received a Wealden grant to complete their funding. It is understood that drawings are now being prepared to support a formal planning application. Plans to be looked at by Council before Planning permission be applied for. NOTED
- 6. <u>Tree Planting:</u> The agreed tree planting will take place on the weekend of the 28/29th March. The work will be done by volunteers the maintenance crew will check the sites beforehand to ensure there are no obstructions and afterwards, that the trees have been planted in the agreed places. NOTED
