This issue was previously discussed at the Finance Committee meeting of 7th July, with business representatives present, although the written submissions arrived at very short notice. After a lengthy discussion, Committee resolved as follows: "that the Council would engage fully and use its reasonable endeavours to contribute the things it has control over, taking into account HMG, law, Guidance and insurance conditions, and conditional on clear wide support from businesses and affected residents."

Although positive, this resolution was clearly (and understandably) lacking in specificity, and if something practical is to be done while the need for business recovery is still pressing, further discussion is needed. The main areas of Parish Council control are its open spaces, hence this meeting. Additionally, following the F&P meeting, Cllr McNally made some outline suggestions to take things forward, and these are included with the backing papers. For Committee to decide what the Council is prepared to offer and on what conditions.

Forest Row: A plan for the transition out of lockdown

We ask for support from the parish council to ease the consequences of the COVID-19 crisis.

The economic crisis

Retail in Forest Row (and nationally) has been struggling over the last 2 years before COVID-19 arrived, and the village has seen a number of closures and empty shop spaces¹. During the period of COVID-19 Forest Row has witnessed the permanent closure of at least 7 retailers² resulting in an approximate loss of 36 local jobs. 36 jobs at an average of 25 hours a week on an average wage of £10 per hour, represents a local wage loss of about £500,000³. Other local businesses have furloughed staff and are not in a position to employ students returning from university during the holidays, adding further to the loss of local wages.

Restaurants and Pubs

Forest Row's restaurants and pubs collectively employ (full and part time) over 150 staff with a combined wage bill in excess of £2 million per year into the local economy. Indirectly, these businesses spend approximately £200,000 with local suppliers. For example, Java and Jazz source cakes locally (Forest Row) at a cost of £25,000 per year. The summer is crucial to the profit of many of these businesses. This period, alongside 3 weeks in December, covers bills for the rest of the year. Therefore, the COVID-19 crisis could not have come at a worse time.

Case Study: Java and Jazz

- Trading at 60% of turnover since lockdown.
- Java and Jazz usually employs 30 staff from Easter In both full time and part time roles.
- 14 staff currently employed
- 18 staff currently furloughed (some staff have returned home and are working at Java because they would otherwise have no income; some furloughed staff earn more on furlough than returning to part time work; others are living with vulnerable people)

Case Study 2: The Hop Yard

Opened off licence and food.

- Trading at 20% of turnover since lockdown.
- 10 staff furloughed (this has reduced to 5 since the easing of lockdown on July 4th)
- The Hop Yard usually employs an additional 2 or 3 summer staff, which is unlikely to this summer because capacity has been reduced to 1/3.

No pub or restaurant is expecting sales over 60% of last year's takings because they will not be able to operate at full capacity in their internal space.

Excluding the loss of revenue for the individual businesses, the consequential loss to the Forest Row economy is expected to be approaching £1 million⁴, some of which can be recovered if we can collectively act and quickly create usable outdoor spaces that make Forest Row an attractive destination.

Outdoor space

We propose the closure of Hillside and the square end of Lower Road to vehicles for 3 months (at certain hours), relocating parking to another area and providing more seating areas for pubs and restaurants (see plan below). This will also resolve the social distancing issues of the narrow pavement along Hillside (especially for wheelchair access). Traffic calming measures will be essential to ensure public safety.

Part 1: A Village on the Green

A joint business group & PC branded Village Market initiative. It could be similar in feel to the Xmas & Easter Frow business trails. This will offer maximum opportunity for all retailers to be part of an event that celebrates the diversity of FROW businesses and remind parishioners and others outside of FROW what the village offers. A FROW village market as opposed to the normal market days. Offering all fresco sampling of drinks, foods, haircuts, products, services - a chance to broadcast what the PC does - a sort of pop-up village on the green. Perhaps a live music stage to celebrate the talent.

Location: Foresters Green or if weather inclement PC Car Park.

When: End of July? Mid August? A two day event to accommodate all comers. Hours: 11.00 - 17:00 so minimal impact on residents.

Strengths:

A showcase of the village in one place celebrating all that is to offer - a village taster menu if you will - so that residents and consumers from outside the parish get a snapshot of why they should visit and enjoy the uniqueness of Forest Row.

Equality of representation for all businesses. It is up to them whether they take advantage. No obvious competitive advantage to any particular business.

Opportunity to offer special deals / discounts at actual stores, bars, restaurants etc.

No noise impact on residents

PR opportunites

Weaknesses:

Issue of managing demand and footfall especially regarding safe distancing though we have a better understanding of this than a few months ago

Cost - it would need contributions from businesses and marketing support.

Logistics - litter, toilets etc.

Opportunities:

As outlined above.

Threats:

Management of footfall, expectations and cohesiveness. However we can manage the first, we will have to manage the second and if the business group and PC work fast, efficiently and with an entrepreneurial spirit most issues can be surmounted.

Please note: This is a partnership. Costs cannot be covered solely by the PC.

Part 2: The Village 'Cafe' Culture

I propose that the PC allows certain areas of PC land to be (literally) ring fenced for seating and tables for ALL restaurants and pubs/bars customers to use. Suggest Hillside (not War Memorial), parts of Foresters Green and other spaces deemed appropriate by the PC. No roads to be closed ot calmed.

These will be takeaway only and no table service will be allowed. This is to avoid potential issues over customers sitting at venue specific tables and consuming food from other venues and ensures no obvious competitive advantage.

Supply of seating & tables to be decided but a joint PC & business initiative is recommended.

The PC will be indemnified by the businesses against liability for accidents etc resulting from anti-social or drink related accidents.

Litter clean-up will be the responsibility of the venues.

Areas will be 'dressed' in bunting, umbrellas (maybe a beach) and generally be attractive and fun whilst adhering to safe distancing regulations. Propose this be a joint initiative as above. All furniture to be removed to storage by 7pm.

Hours to be weekend only (Sat / Sun) 10 - 7pm. ASAP to last weekend in September.
