COMMENT: We object to this application on the following grounds:

- Industrial unit use is highly likely to increase traffic to the site & therefore through the AONB.
- A264 access is off dangerous bends & therefore unsuited to vans & large vehicles turning in this location.
- 3. Detrimental to the rural nature of the village of Hammerwood & surrounding agricultural land.
