### 3 & 4. RECORDS OF MEETING OF 30th MARCH 2021 / CLARIFICATION OF ACTIONS

The main purpose of this EGM is to address two matters of urgent business. It is therefore proposed to defer items of ordinary business to the next Ordinary Meeting.

5. **DECLARATION OF INTERESTS.** Such a declaration should only be needed if any Member has a financial interest in the main business of the meeting (which is inherently unlikely).

Given the nature of the agenda, there will be no general Chairman's comments or Clerk's report.

6. TO CONSIDER A REWORDING OF RESOLUTIONS NOS. C92/20 & C93/20 IN COMPLIANCE WITH A DIRECTION FROM THE MINISTRY OF HOUSING, COMMUNITIES & LOCAL GOVERNMENT.

Council may have wondered what happened to our application to the Secretary of State for permission to apply to the PWLB, which we signed off in December 2020. We knew there were significant delays in Whitehall due to the pandemic, but since more than six months had passed, I chased it up directly in June. I discovered the named contact officer no longer worked for the Ministry, and more seriously, that our entire dossier had been 'misplaced'. I reconstituted and resent the dossier immediately, but the new contact officer has replied with a number of requests for refinement of the material. Most seriously, we were told that a set form of words for the appropriate resolution of Council is a requirement of the process – a condition not previously advised. The required wording (which encompasses both C92/20 & C93/20) is as follows:

"At the Forest Row Parish Council meeting of 3<sup>rd</sup> November 2020, it was RESOLVED to seek the approval of the Secretary of State for Housing, Communities and Local Government to apply for a PWLB loan of £250,000 over the borrowing term of twenty years for the purpose of purchasing the Forest Row former Household Waste Recycling Centre for use as a community re-use/recycling facility. The annual repayments will come to around £15,000. It is also intended to increase the council tax precept for the purpose of loan repayments by 3.9% which is the equivalent of an additional £7 per year (which was supported in a precept increase consultation of the electorate in August 2020)."

Council is invited to adopt the above wording. The other 'refinements' sought are points of clarification which can be answered from the existing papers.

#### 7. TO CONSIDER A REQUEST FROM THE FOREST ROW FESTIVAL COMMITTEE

The Forest Row Festival Committee have written in to ask if Council will agree to make Foresters' Green available for a festival event on  $18^{th}$  /  $19^{th}$  September this year. The format of any such event (or even whether it will take place at all) is still under discussion by the Committee and in consultation with the licensing authorities, but they have pointed out that unless they can be sure of a venue, no plans can reasonably be made.
